RESOLUTION TO ESTABLISH FEES FOR TOWN OF BRIDGE CREEK LIQUOR AND FERMENTED MALT BEVERAGE LICENSES

WHEREAS, the Town of Bridge Creek is authorized by Wisconsin Statutes to regulate the sale of alcohol beverages within its jurisdiction and to establish reasonable fees for licenses; and

WHEREAS, it is deemed necessary and appropriate to establish a schedule of fees for the various classes of liquor and fermented malt beverage licenses, as well as operator and provisional operator licenses, to cover the costs of administration, regulation, and enforcement.

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Bridge Creek, Eau Claire County, Wisconsin, that the following annual fees for liquor and fermented malt beverage licenses, and operator licenses, are hereby established, effective upon adoption of this resolution:

Alcohol Beverage License Fees:

- Class "A" Beer (Fermented Malt Beverage): \$100.00
 - Allows for the sale of beer in original, unopened packages for off-premises consumption.
- Class "A" Liquor (Intoxicating Liquor): \$350.00
 - Allows for the sale of intoxicating liquor in original, sealed packages for off-premises consumption.
- Class "B" Beer (Fermented Malt Beverage): \$100.00
 - Allows for the sale of beer for on-premises and off-premises consumption.
- Class "B" Liquor (Intoxicating Liquor): \$300.00
 - Allows for the sale of intoxicating liquor by the glass for on-premises consumption.
- Class "C" Wine: \$50.00
 - Allows for the sale of wine by the glass or in an opened original container for on-premises consumption only.
- Producer Off-Site Full-Service Retail Outlets: \$300
Allows a licensed alcohol beverage producer (like a brewery, winery, or distillery) to sell their products, and sometimes other alcohol beverages, directly to consumers at a location separate from their main production facility.
- Temporary Alcohol License: \$10
 - Any individual or entity that wants to sell alcoholic beverages to consumers or allow consumption in a public place must get an alcohol beverage license for one day.

Operator License Fees:

- Provisional Operator License: \$32 for renewals and \$32 for new licenses

A temporary license allowing an individual to serve alcohol for a limited period (e.g., up to 60 days) while their full Operator's License application is being processed.

- Operator's License: \$32 for renewals and \$32 for new licenses

Authorizes an individual to serve alcoholic beverages.

BE IT FURTHER RESOLVED that all applications for the aforementioned licenses shall be submitted to the Town Clerk, along with the required fee and any other documentation as may be prescribed by state law or town ordinance.
